



Natural Gas Right-of-way Guidelines

Ensuring safety and reliability



SCE&G strives to maintain safe and reliable standards for its natural gas pipeline system. To protect public safety and ensure the continuous delivery of natural gas to customers, SCE&G must control and restrict certain activities within its rights of way. This brochure provides a basic overview of SCE&G right-of-way guidelines.

What is a “Right-of-way”?

“Right-of-way” refers to the corridor SCE&G uses to build and maintain natural gas transmission and distribution facilities in order to serve its customers.

SCE&G, as with all utilities, is required to perform regular maintenance on its rights of way. A clear right-of-way allows for:

- Unrestricted entry and access to all facilities at all times for regular maintenance and during emergency situations.
- Easy identification and monitoring of transmission and distribution facilities.
- Preventing third-party damage.
- Uninterrupted gas supply.

Right-of-way Guidelines

SCE&G may allow certain improvements and activities in its rights of way. However, SCE&G will not assume responsibility, financial or otherwise, for any such improvements directly or indirectly damaged as a result of its operation and maintenance of its facilities.

The following activities are generally allowed within the natural gas right-of-way without a permit from SCE&G:

- Planting of lawn grasses
- Planting of row or cover crops
- Planting of vegetable gardens
- Planting of flowers
- Planting of small shrubs
- Normal agricultural activities



Structures/activities that require a permit

SCE&G may allow some structures and activities within rights of way in certain instances. If allowed, certain guidelines apply and a permit may be required. Examples include:

- Fences* (see details below)
- Water lines/sprinklers (all sprinkler heads must be three feet (minimum) from pipeline)
- Communication cables
- Driveways
- Parking/parking lots
- Roadways
- Electric lines
- Overhead cables
- Sewer lines
- Drainage ditches
- Logging roads
- Excavation or filling
- Blasting

** Fences or continuous hedges that block visual inspection or interfere with access to SCE&G facilities are prohibited within the right-of-way. Fences permitted by SCE&G to cross its right-of-way must be designed to allow at least a 12' opening centered on the pipeline and must cross at or near 90 degrees. Gates are permissible, as long as they allow for at least a 12' opening. If gates are to be locked, SCE&G must be allowed to install its own locks on the gates. Locks will be installed in such a manner as to allow both the landowners and SCE&G unimpeded access to the property. Placement of posts must be a minimum of two feet from the pipeline and hand dug.*

Prohibited structures/activities

Some structures and activities within the rights of way do not allow for ongoing maintenance and access requirements, or may create safety concerns for you, your neighbors or SCE&G employees.

Examples of structures or activities prohibited within SCE&G's natural gas rights of way include:

- Houses
- Barns
- Pole sheds
- Permanent dog and animal shelters
- Picnic shelters
- Septic tanks or drain fields
- Satellite equipment or antennas
- Basketball goals (in-ground)
- Set poles
- Abandoned materials
- Ponds, pond dams
- Water retention/diversion
- Wells
- Guy wires
- Valves
- Electrical boxes
- Signs
- Decorative lights
- Street lamps

- Mail boxes
- Trees
- Large shrubs
- Curbing
- Concrete pads
- Stockpiled materials
- Mobile homes
- Deer stands or blinds
- Playground equipment
- Dumpsters, trash dumps or junk cars
- Swimming pools
- Decks or porches
- Roof overhangs
- Breezeways
- Patios
- Outdoor grills or pits
- Camping sites or campers
- Tree farms (including Christmas tree farms)

Permitting Guidelines

Consult SCE&G early in your planning

SCE&G must review and approve all plans for construction proposed on SCE&G rights of way. To expedite your construction or excavation projects, contact SCE&G Gas Operations and prepare to submit your plan before applying for permits or committing to construction.

Notify SCE&G before construction begins **NO** construction or excavation activities of any kind, including blasting, should be done on SCE&G right-of-way before SCE&G employees have established the exact location and elevation of all affected facilities and the limits of the right-of-way. SCE&G employees must be present during any construction or excavation activities on or around the company's facilities or rights of way, unless otherwise permitted by SCE&G. Excavation within three feet of SCE&G facilities is strictly forbidden without an SCE&G representative on site.
